Payment in full is due by April 26th, otherwise your spot will be forfeited and filled by another team on the waiting list. Any unsuccessful entries will be refunded by mail the week of May 4th. No refunds will be given to accepted teams after May 1st, 2015.

In addition to the 100 entries, we will reserve 3 spots for tournament employees and allow additional spots for sponsors and new boat buyers from D&R at the discretion of the tournament committee.
